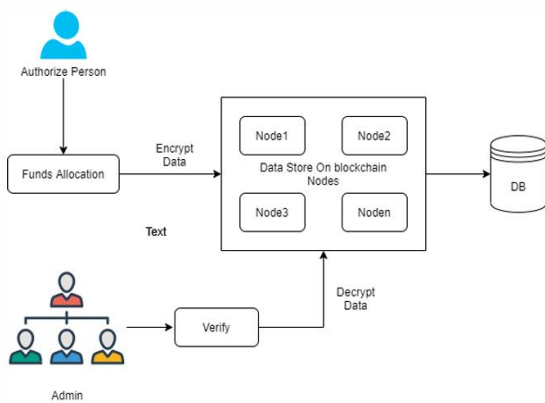
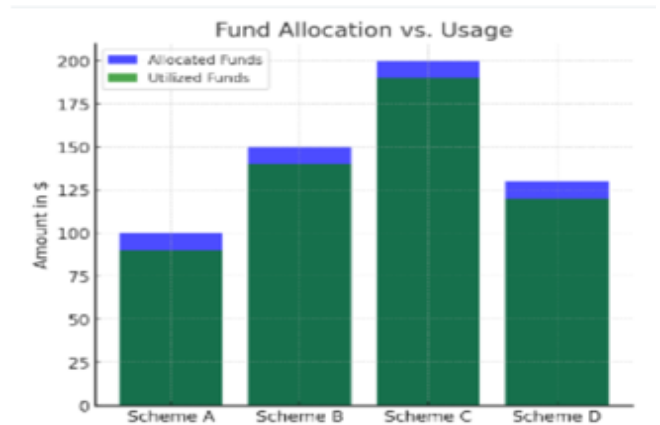
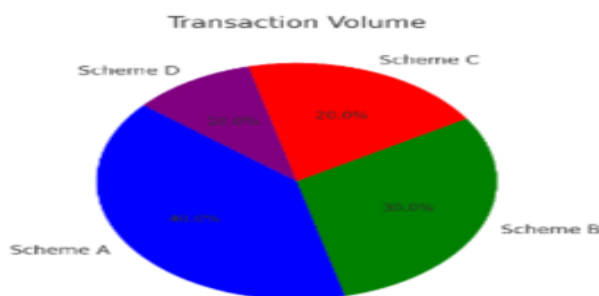


Fig. 1: Architecture Diagram
